### **A RESOLUTION AUTHORIZING CHEROKEE NATION MARSHAL SERVICE TO DONATE A SURPLUS VEHICLE TO DELAWARE COUNTY SHERIFF'S OFFICE IN DELAWARE COUNTY**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Marshal Service has the following equipment in its inventory that has been deemed surplus:

**WHEREAS**, the Cherokee Nation Marshal Service desires to donate this equipment in “as- is” condition.

**WHEREAS**, the Delaware County Sheriff’s Office located within the Cherokee Nation jurisdictional boundaries, operates on limited funds and the donation of this vehicle would benefit them greatly.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that the Tribal Council hereby authorizes Cherokee Nation Marshal Service to donate this surplus vehicle to the Delaware County Sheriff’s Office in Delaware County as set out above.
