### **A RESOLUTION CONFIRMING THE NOMINATION OF ELMER TADPOLE AS A GOVERNING BOARD MEMBER OF THE CHEROKEE NATION HOME HEALTH SERVICES, INCORPORATED**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Home Health Services, Inc. was created and authorized as a Tribal Corporation by Article VI, Section 10 of the Constitution of the Cherokee Nation, Legislative Act 11-85 and Legislative Act 3-90. The Governing Board was created and authorized by Resolution 95-97 and by Title 18, Section 21 of the Cherokee Nation Code Annotated (CNCA);

**WHEREAS**, the Principal Chief is authorized to select the members of the Board subject to majority vote of the Council of the Cherokee Nation;

**WHEREAS**, the term of Office of one of the five (5) Board Members is now vacant; and

**WHEREAS**, Elmer Tadpole is duly qualified to fill this vacancy pursuant to Article III, Section 3.01, of the Bylaws of the Cherokee Nation Home Health Services, Inc.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Elmer Tadpole is hereby confirmed as a Governing Board Member of the Cherokee Nation Home Health Services, Inc. as authorized by Article IX of the Articles of Incorporation of the Cherokee Nation Home Health Services, Inc.
