**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, Cherokee Nation Waste Management, LLC is a Limited Liability Company created and authorized under the Cherokee Nation Limited Liability Company Act;

**WHEREAS**, the Principal Chief is authorized to nominate the members of the Board of Directors subject to a majority vote of the Council of the Cherokee Nation;

**WHEREAS**, Carlile Roberts, is duly qualified and should be appointed as a member of the Board of Directors of Cherokee Nation Waste Management, LLC.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Carlile Roberts is hereby confirmed as a member of the Board of Directors of Cherokee Nation Waste Management, LLC, and its successors, for a term from December 15, 2009 until December 31, 2012.
