### **A RESOLUTION CONFIRMING THE NOMINATION OF DEWAYNE MARSHALL AS A BOARD MEMBER OF THE CHEROKEE NATION SEQUOYAH HIGH SCHOOL BOARD OF EDUCATION**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people; and,

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America; and,

**WHEREAS**, the Cherokee Nation Sequoyah High School Board of Education was established by Cherokee Nation Resolution No. 72-86; and

**WHEREAS**, the appointed members of the board are authorized by Article II Section 1 of Resolution No. 72-86 to appoint one (1) member to the board; and,

**WHEREAS**, the members of the board have selected Dewayne Marshall to serve as the fifth member of the board, upon approval by the Council of the Cherokee Nation; and

**WHEREAS**, Dewayne Marshall is duly qualified to serve on Cherokee Nation Sequoyah High School

Board of Education.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Dewayne Marshall is hereby confirmed as a Board Member of the Cherokee Nation Sequoyah High School Board of Education, for a term of five (5) years, commencing April, 2017 until April, 2021.
