**A RESOLUTION CONFIRMING THE REAPPOINTMENT OF TOMMYE SUE BRADSHAW WRIGHT AS A BOARD MEMBER OF CHEROKEE NATION BUSINESSES, LLC**  
**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people; and

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and

**WHEREAS**, Cherokee Nation Businesses, LLC is a tribal Limited Liability Company created and authorized under the Cherokee Nation Limited Liability Company Act; and

**WHEREAS**, the Principal Chief, as representative of the Cherokee Nation is authorized to select the members of the Board of Directors, subject to majority vote of the Council of the Cherokee Nation; and,

**WHEREAS**, Tommye Sue Bradshaw Wright is duly qualified and should be reappointed to Seat 9 as a member of the Board of Directors of Cherokee Nation Businesses, LLC and its successors.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Tommye Sue Bradshaw Wright is hereby confirmed as a member of the Board of Directors of Cherokee Nation Businesses, LLC and its successors, filling seat 9 (nine), a term beginning in August 2019 and expiring August 31, 2022.
