### **A RESOLUTION CONFIRMING THE RENOMINATION OF AMON BAKER AS A BOARD MEMBER OF THE CHEROKEE NATION SEQUOYAH HIGH SCHOOL BOARD OF EDUCATION**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people; and,

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America; and,

**WHEREAS**, the Cherokee Nation Sequoyah High School Board of Education was established by Cherokee Nation Resolution No. 72-86; and

**WHEREAS**, the Principal Chief is authorized by Article II Section 1 of Resolution No. 72-86 to appoint two (2) members to the board; and,

**WHEREAS**, Amon Baker is duly qualified to serve on Cherokee Nation Sequoyah High School Board of Education, seat four (4), and has been selected by the Principal Chief; and therefore,

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Amon Baker is hereby confirmed as a Board Member of the Cherokee Nation Sequoyah High School Board of Education, for a term of five (5) years, commencing November 2015 until November 2020.
