### **A RESOLUTION AUTHORIZING CHEROKEE NATION WAREHOUSE TO DONATE SURPLUS OFFICE EQUIPMENT TO THE VIAN PEACE CENTER IN SEQUOYAH COUNTY**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Warehouse has the following office equipment in its inventory that has been deemed surplus:

- CN Mahogany Desk - CN # 57381
- Mahogany Hutch - C N # 48544
- Office Chair - CN # 69707
- Four Drawer File Cabinets - CN # 015460
- Four Drawer File Cabinets - CN # 016891
- Four Drawer File Cabinets - CN # 60943

**WHEREAS**, the Cherokee Nation Warehouse desires to donate this office equipment in “as- is” condition.
