LEGISLATIVE ACT 11-91
AN ACT RELATING TO CHEROKEE NATION LAW REGARDING COMPENSATION OF COUNCIL MEMBERS GENERALLY: AMENDING CNCA SECTION 6-3-1: ADDING NEW ITEMS AND DECLARING AN EMERGENCY
BE IT ENACTED BY THE CHEROKEE NATION:
Section 6-3-1. Compensation of Council Members generally
Council members shall not receive a salary for conducting the official duties of their office. Council members shall receive \$400.00 per month for travel, plus \$457.49-\$50.00 per official meeting of Standing Committees by members of the Council. No Council member shall be reimbursed for more than eight (8) meetings per calendar month.
