BE IT ENACTED BY THE CHEROKEE NATION:

Section 6-2-1: Standing Committees - Establishment

The following Standing Committees of the Council are hereby established by this Amendment:

- (1) Community Development/Tribal Services
- (2) Rules Committee
- (3) Resources Committee
- (4) Employment Committee
- (5) Executive and Finance Committee
- (6) Education Committee (7) Health Committee

This Act shall supersede any other Act or Resolution enacted prior to this enactment.
