## A RESOLUTION CONFIRMING THE REAPPOINTMENT OF JAMES AMOS AS A COMMISSIONER OF THE HOUSING AUTHORITY OF THE CHEROKEE NATION BOARD OF COMMISSIONERS

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Housing Authority of the Cherokee Nation was created and authorized by Section 1057 of Title 63 of the Oklahoma Statutes;

WHEREAS, the Principal Chief is authorized to select the members of the Commission subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, there is a vacancy on the Housing Authority of Cherokee Nation Board;

WHEREAS, James Amos is hereby nominated for reappointment as authorized by the Bylaws of the Housing Authority of the Cherokee Nation and Section 1058 of Title 63 of the Oklahoma Statutes;

**WHEREAS,** James Amos is duly qualified to fill this board position pursuant to the Bylaws of the Housing Authority of the Cherokee Nation.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that James Amos is hereby reconfirmed as a Commissioner of the Housing Authority of the Cherokee Nation as authorized by the Bylaws of the Housing
