**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Health Program has the following automated external defibrillator (AED) that has been deemed as surplus:

**WHEREAS**, Westville Public School located within the Cherokee Nation jurisdictional boundaries in Adair County is in need of an automated external defibrillator (AED);
