### **A RESOLUTION CONFIRMING THE NOMINATION OF FARRELL MACKEY PRATER AS A MEMBER OF THE CHEROKEE NMATION REGISTRATION COMMITTEE**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Registration Committee was created under Article III, Section 2 of the Constitution of 1975;

**WHEREAS**, the Principal Chief is authorized to appoint the Committee members subject to confirmation by majority vote of the Council of the Cherokee Nation;

**WHEREAS**, the term of the Registration Committee members is concurrent with the Principal Chief's term; and

**WHEREAS**, Farrell Mackey Prater is duly qualified to fill this vacancy pursuant to Article III, Section 2 of the Constitution of 1975.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Farrell Mackey Prater is hereby confirmed as a member of the Registration Committee.
