**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Waste Management, LLC is a Limited Liability Company created and authorized under the Cherokee Nation Limited Liability Company Act;

**WHEREAS**, the Principal Chief is authorized to appoint the members of the Commission subject to majority vote of the Council of the Cherokee Nation; and

**WHEREAS**, Shaun A. Shepherd is duly qualified and should be appointed as a member of the Board of Directors of Cherokee Nation Waste Management, LLC, to fill this vacancy of Seat Three (3) pursuant to the laws of the Cherokee Nation;

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Shaun A. Shepherd is hereby confirmed as a member of the Board of Directors of Cherokee Nation Waste Management, LLC, and its successors, for a term from April 30, 2013, until April 30, 2016.
