### **A RESOLUTION CONFIRMING THE NOMINATION OF T. LUKE BARTEAUX AS AN EDITORIAL BOARD MEMBER OF THE CHEROKEE PHOENIX**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Free and Independent Press for the Cherokee Nation, Editorial Board was created and authorized by Legislative Act 16-09;

**WHEREAS**, T. Luke Barteaux is nominated by Principal Chief Bill John Baker to serve a six-year term as an Editorial Board Member of the Cherokee Phoenix from October 31, 2014 through October 31, 2020, as authorized by Legislative Act 16-09; and

**WHEREAS**, T. Luke Barteaux is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that T. Luke Barteaux is hereby confirmed as a Board Member of the Editorial Board of the Cherokee Phoenix for a six-year term effective October 31, 2014 through October 31, 2020 as authorized by Legislative Act 16-09, the Act of June 15, 2009.
