A RESOLUTION CONFIRMING THE REAPPOINTMENT OF ROBERTA GIBSON AS A BOARD MEMBER OF THE CHEROKEE NATION SEQUOYAH HIGH SCHOOL BOARD OF EDUCATION

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Sequoyah High School Board of Education was established by Cherokee Nation Resolution No. 72-86;

WHEREAS, the Principal Chief is authorized to appoint Office #5 seat on the Board, subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, the current term for Office #5 seat on the Board expired July 2013 and Roberta Gibson has continued to serve;

WHEREAS, Roberta Gibson is duly qualified to be reappointed to Office #5 seat on the Board.

BE IT RESOLVED BY THE CHEROKEE NATION, that Roberta Gibson is hereby reconfirmed as a Board Member of the Cherokee Nation Sequoyah High School Board for the term of (5) five years from October 31, 2013 until September 30, 2018.
