**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation has had extensive experience administering energy assistance programs for low-income households.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that the Tribal Council hereby authorizes an application be submitted to the U.S. Department of Health and Human Services for FY 2012 funding for a Low Income Home Energy Assistance Program (LIHEAP), and that Chad Smith, Principal Chief, and/or his authorized delegate(s) shall be authorized to negotiate all contract(s) and any amendments thereto.
