### **A RESOLUTION CONFIRMING THE RE-NOMINATION OF STEVE WILSON AS A COMMISSIONER OF THE CHEROKEE NATION TAX COMMISSION**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Tax Commission Board of Commissioners was created and authorized by Title 68 §11 of the Cherokee Nation Code Annotated;

**WHEREAS**, Seat 3 of the Cherokee Nation Tax Commission Board of Commissioners is currently vacant;

**WHEREAS**, Steve Wilson is duly qualified to fill this vacancy, pursuant to the laws of the Cherokee Nation.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that the Tribal Council of the Cherokee Nation hereby confirms Steve Wilson as a commissioner of the Cherokee Nation Tax Commission, with a term beginning February, 2020 and ending February, 2023.
