### **A RESOLUTION ADOPTING THE US-75/EW-0290 ROAD INTERSECTION AS A PRIORITY PROJECT FOR TRIBAL TRANSPORTATION PROGRAM SAFETY FUNDING**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, Title 23 United States Code §202(e) provides for a 2% set-aside of Tribal Transportation Program funding for purposes of funding highway safety projects throughout Indian country;

**WHEREAS**, the Federal Highway Administration published a notice of opportunity on September 21, 2017, soliciting eligible projects for Tribal Transportation Program Safety Funding;

**WHEREAS**, the Cherokee Nation has conducted extensive research concerning the highway safety needs within its jurisdiction and in doing so has identified the US-75-EW-0290 Road Intersection as a candidate for safety improvements.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that the Federal Highway Administration is hereby authorized to pursue all matters necessary to fund the improvement of the US-75-EW-0290 Road Intersection, which is herein deemed a priority for Tribal Transportation Program Safety Funding.
