A RESOLUTION CONFIRMING THE APPOINTMENT OF FRANK DELOZIER AS A COMMISSIONER OF THE CHEROKEE NATION GAMING COMMISSION

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Gaming Commission was established and codified under Title IV of the Cherokee Nation Code Annotated;

**WHEREAS**, the Principal Chief is authorized to select the members of the Commission subject to majority vote of the Council of the Cherokee Nation;

**WHEREAS**, Frank Delozier is duly qualified to be reappointed as Commission pursuant to Section 12, Chapter 2, Title IV of the Cherokee Nation Code Annotated.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Frank Delozier is hereby confirmed reappointed as a Commissioner of the Cherokee Nation Gaming Commission, Seat One (1), for a term of three (3) years as authorized by Section 21, Chapter 2, Title 4 of the Cherokee Nation Code Annotated, from September 20, 2021 to September, 2024.
