### **A RESOLUTION AUTHORIZING CONFIRMATION OF WILLIAM GRASS AS A MEMBER OF THE BOARD OF MANAGERS OF CHEROKEE MEDICAL SERVICES, LLC**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, Cherokee Medical Services, LLC is an Oklahoma Limited Liability Company created and authorized under the laws of the State of Oklahoma;

**WHEREAS**, the Principal Chief, as representative of the Cherokee Nation, is authorized to select the members of the Board of Managers subject to a majority vote of the Council of the Cherokee Nation;

**WHEREAS**, William Grass is duly qualified and should be appointed as a member of the Board of Managers of Cherokee Medical Services, LLC, and its successors, for a term that expires September 30, 2012, and

pursuant to the attached Memorandum of Action of the Principal Chief of the Cherokee Nation.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that William Grass is hereby confirmed as a member of the Board of Managers of Cherokee Medical Services, LLC, and its successors, for a term that expires September 30, 2012.
