### **A RESOLUTION ALLOWING CHEROKEE NATION TO WORK WITH THE UNITED STATES DEPARTMENT OF AGRICULTURE, NATIONAL AGRICULTURE STATISTICAL SERVICE (NASS)**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the USDA's National Agricultural Statistics Service (NASS) conducts hundreds of surveys every year and prepares reports covering virtually every aspect of U.S. agriculture;

**WHEREAS**, Cherokee Nation can conduct the census of Cherokee citizens and apply for funding from the USDA for conducted said census;

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Cherokee Nation may pursue opportunities with the USDA to conduct a census for the National Agricultural Statistics Service (NASS) and may apply for any funding that may be available for conducting said census.
