### **A RESOLUTION AUTHORIZING CHEROKEE NATION WAREHOUSE TO DONATE SURPLUS OFFICE EQUIPMENT TO WARPONY COMMUNITY OUTREACH IN CHEROKEE COUNTY**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Warehouse has the following office equipment in its inventory that has been deemed surplus:

- 1 Stackable washer and dryer, Whirlpool - CN # N/A
- 1 Stackable washer and dryer, Crosslin - CN # N/A
- 1 Stackable washer and dryer, Maytag - CN # N/A
- 1 Dryer, GE - CN # 6783
