### **A RESOLUTION CONFIRMING THE REAPPOINTMENT OF LINDA O'LEARY AS REGISTRAR FOR THE CHEROKEE NATION REGISTRATION COMMITTEE**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Registrar was created under Article IV, Section 2 of the Constitution;

**WHEREAS**, the Principal Chief is authorized to appoint the Registrar subject to confirmation by majority vote of the Council of the Cherokee Nation;

**WHEREAS**, the term of the Registrar is concurrent with the Principal Chief's term; and

**WHEREAS**, Linda O'Leary is duly qualified to fill this vacancy pursuant to Article IV, Section 2 of the Constitution.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Linda O'Leary is hereby confirmed as the Registrar of the Registration Committee for a term beginning September 14, 2015 and ending August 14, 2019
