**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Information Technology Department has the following office equipment in its inventory that has been deemed surplus:

**WHEREAS**, the Cherokee Nation Information Technology Department desires to donate this office equipment in "as- is" condition.

**WHEREAS**, the Moffett Police Department located within the Cherokee Nation jurisdictional boundaries, operates on limited funds and the donation of this office equipment would benefit them greatly.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that the Tribal Council hereby authorizes Cherokee Information Technology Department to donate this surplus office equipment to the Moffett Police Department located in Sequoyah County as set out above.
