### **A RESOLUTION AUTHORIZING CHEROKEE NATION WAREHOUSE TO DONATE SURPLUS OFFICE EQUIPMENT TO CEDAR TREE BAPTIST CHURCH IN CHEROKEE COUNTY**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Warehouse has the following equipment in its inventory that has been deemed surplus:

CN #25325 - Typewriter Stand  
CN #39201 - Small Hutch  
CN #69401 - Double Pedestal Desk  
CN #66233 - Red Office Chair

**WHEREAS**, the Cherokee Nation Warehouse desires to donate this equipment in “as- is” condition.

**WHEREAS**, the Cedar Tree Baptist Church located within the Cherokee Nation jurisdictional boundaries, operates on limited funds and the donation of this office equipment would benefit them greatly.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that the Tribal Council hereby authorizes Cherokee Nation Warehouse to donate this surplus office equipment to Cedar Tree Baptist Church located in Cherokee County as set out above.
