### **A RESOLUTION CERTIFYING COMPLIANCE WITH 24 CFR Ch. IX (4-1-03 Edition) 1003.604 Citizen Participation**

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation is desirous of participation in the ICDBG grant program through submission of an application for Head Start for Fiscal Year 2017;

WHEREAS, HUD has set out requirements for citizen participation as a prerequisite to application;

WHEREAS, the Cherokee Nation is continuously seeking and responding to citizen questions and comments through ongoing processes of the Tribe in order to better serve its citizenry;

WHEREAS, the Cherokee Nation has met the specific requirements of HUD as set out through public hearings, response to comments, and requests made by respondents;

BE IT RESOLVED BY THE CHEROKEE NATION, that the Tribal Council hereby certifies that it has met the requirement of HUD set out in *24 CFR Ch. IX (4-1-03 Edition 1003.604 Citizen Participation)* for the ICDBG grant application to be submitted on or by May 18, 2017.
