**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Warehouse has the following equipment in its inventory that has been deemed surplus:

Item # 3425 Norlake Freezer

Item #3752 Stove

Item #3530 Stove

**WHEREAS**, the Cherokee Nation Warehouse desires to donate this equipment in “as- is” condition.

**WHEREAS**, the Mid County Community Organization located within the Cherokee Nation jurisdictional boundaries, operates on limited funds and the donation of this equipment would benefit them greatly.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that the Tribal Council hereby authorizes Cherokee Nation Warehouse to donate this surplus equipment to Mid County Community Organization in Adair County as set out above.
