A RESOLUTION CONFIRMING THE REAPPOINTMENT OF VALERIE ROGERS AS A BOARD MEMBER OF THE COMPREHENSIVE CARE AGENCY (PACE)

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people; and

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and

WHEREAS, the Cherokee Nation Comprehensive Care Agency (PACE) was created and authorized by Article V, Section 7 of the Constitution of the Cherokee Nation and Legislative Act 03-04;

WHEREAS, the Principal Chief is authorized by Section 5.E. of LA-03-04 to select the members of the board, subject to the majority vote of the Council of the Cherokee Nation.

WHEREAS, Valerie Rogers is duly qualified and has been selected by the Principal Chief of the Cherokee Nation to serve as a governing board member of the Cherokee Nation Comprehensive Care Agency (PACE).

BE IT RESOLVED BY THE CHEROKEE NATION, that Valerie Rogers is hereby confirmed as a member of the Cherokee Nation Comprehensive Care Agency (PACE) and its successors, a term of (3) years beginning in October 2019 and expiring October 31, 2022.
