### **A RESOLUTION CONFIRMING THE APPOINTMENT OF BRANDI PAYTON AS A BOARD MEMBER OF THE COMPREHENSIVE CARE AGENCY (PACE)**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people; and

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and

**WHEREAS**, the Cherokee Nation Comprehensive Care Agency (PACE) was created and authorized by Article V, Section 7 of the Constitution of the Cherokee Nation and Legislative Act 03-04;

**WHEREAS**, the Principal Chief is authorized by Section 5.E. of LA-03-04 to select the members of the board, subject to the majority vote of the Council of the Cherokee Nation.

**WHEREAS**, Brandi Payton is duly qualified and has been selected by the Principal Chief of the Cherokee Nation to serve as a governing board member of the Cherokee Nation Comprehensive Care Agency (PACE).

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Brandi Payton is hereby confirmed as a member of the Cherokee Nation Comprehensive Care Agency (PACE) and its successors, a term of (3) years beginning in October 2019 and expiring October 31, 2022.
