## A RESOLUTION CONFIRMING THE APPOINTMENT OF CROSBY CONNOR CAUGHRON AS A MEMBER OF THE CHEROKEE NATIONAL HOME HEALTH BOARD OF DIRECTORS

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of selfgovernment on behalf of the Cherokee people; and

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and

**WHEREAS**, the Cherokee Nation Home Health Services, Inc. was created and authorized as a Tribal Corporation by Article VI, Section 10 of the Constitution of the Cherokee Nation, Legislative Act 11-85 and Legislative Act 3-90. The Governing Board was created and authorized by Resolution 95-97 and by Title 18, Section 21 of the Cherokee Nation Code Annotated (CNCA);

**WHEREAS,** the Principal Chief of the Cherokee Nation is authorized to appoint the members subject to confirmation by majority vote of the Council of the Cherokee Nation;

WHEREAS, the term of Office of one of the five (5) Board Members is now vacant; and

**WHEREAS,** Crosby Connor Caughron is duly qualified to fill this vacancy pursuant to Article III, Section 3.01, of the Bylaws of the Cherokee Nation Home Health Services, Inc.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Crosby Connor Caughron is hereby confirmed as a member of the Cherokee Nation Home Health board and will serve a term from December 2019 and expiring December 31, 2023.
