## A RESOLUTION CONFIRMING THE NOMINATION OF LYNDON EMBERTON AS A BOARD MEMBER OF THE CHEROKEE NATION SEQUOYAH HIGH SCHOOL BOARD OF EDUCATION

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of selfgovernment in behalf of the Cherokee people; and,

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America; and,

**WHEREAS**, the Cherokee Nation Sequoyah High School Board of Education was established by Cherokee Nation Resolution No. 72-86; and

**WHEREAS,** the Principal Chief is authorized by Article II Section 1 of Resolution No. 72-86 to appoint two (2) members to the board; and,

**WHEREAS,** Lyndon Emberton is duly qualified to serve on Cherokee Nation Sequoyah High School Board of Education, seat four (4), and has been selected by the Principal Chief; and therefore,

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Lyndon Emberton is hereby confirmed as a Board Member of the Cherokee Nation Sequoyah High School Board of Education, for a term of five (5) years, commencing February 16, 2021 and ending February 28<sup>th</sup> 2026
