WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Warehouse has the following items in its inventory that has been deemed surplus:

Item: 61872- 5 drawer lateral file cabinet (metal) Item: 4386- 5 drawer lateral file cabinet (metal) Item: 68950- 6 drawer lateral file cabinet (metal) Item: 130070- 4 drawer lateral file cabinet (metal) Item: 138617- 4 drawer lateral file cabinet (wooden)
